1. Introduction

Welcome to Buckin' Boots Line Dancing! By signing this form, you agree to the following Terms & Conditions for participation in our 2026 line dancing lessons.

This Agreement is between:

Buckin' Boots Line Dancing ("the Company"), a sole trader registered under **Amy Walton**, Church Farm, 41 Gayton Road, Grimston, King's Lynn, Norfolk, PE32 1BG and **you, the Participant**.

Please read carefully—by confirming your participation, you agree to be bound by these terms.

2. Line Dancing Lessons

- Lessons are 1 hour long with regular breaks.
 - Lessons take place at **Sovereign Quarter Horses, Marshland Hall & Dersingham Social Club** unless otherwise notified.
 - Content, timetable, and delivery may change at short notice.

3. Payment, Refund & Cancellation

- Cost: **£7.50 per person** (exclusive of fees). Full payment must be made to secure a place.
- The Company may postpone or cancel lessons due to illness, extreme weather, COVID-19, or other unforeseen circumstances.
- Participants should ensure travel arrangements are flexible and insured; the Company is not responsible for travel costs.

- Rescheduled lessons: Participants will have a reserved place for the new date. If unable to attend, alternative arrangements may be offered at the Company's discretion. Refunds may also be offered at discretion.
