Introduction

These Terms and Conditions of Sale ("Terms of Sale") set out how you (the **User**) may purchase services and digital products from our website ("the Site"). Please read these Terms carefully before making a purchase.

We are committed to providing a high level of customer service and ensuring you understand your rights relating to any purchase you make. Before completing a purchase, you will be required to confirm acceptance by ticking a box stating "**I accept the Terms and Conditions of Sale.**" By doing so, you agree to be legally bound by these Terms.

We are based in the United Kingdom, and these Terms of Sale are governed by UK law. We do not offer international shipping for physical goods. Digital products may be downloaded worldwide.

Purchase Terms for Services

If you are purchasing as a **consumer** (rather than as a business), you have the right to cancel your purchase within **14 days** of purchase in accordance with the Consumer Contracts Regulations 2013.

If you request a refund after receiving part of a service, any refund issued will be **pro-rated** to reflect the services already provided.

Where services are scheduled to begin within the 14-day cancellation period, you acknowledge that you may lose part or all of your right to cancel once delivery of the service has begun.

Pricing

- All prices are displayed on the Site and are shown **exclusive of VAT**, unless otherwise stated.
- Prices do not include delivery charges, which will be added at checkout where applicable.
- We reserve the right to change prices at any time; however, price changes will not affect orders that have already been confirmed.

While we take care to ensure pricing accuracy, errors may occasionally occur. If a pricing error is identified:

- Where the correct price is **lower**, we will charge the lower amount.
- Where the correct price is **higher**, we will contact you to confirm whether you wish to proceed at the correct price or cancel your order.
- If we are unable to contact you, the order will be cancelled and you will be notified.

We are not obliged to provide products or services at an incorrect price where the error is obvious and could reasonably have been recognised as a mistake.
